1. introduction

The rules in the left column are the old rules of the Club. In the right column is indicated where in the new rules the old rules are implemented (or not). The 'new rules' are one of:

- the CIO Constitution CIO;
- the Articles of WMSC House Limited HOUSE;
- the Club Rules (a new document) RULES.

Note: there is a considerable advantage to using the clauses from the Charity Commission template verbatim as deviating from the template makes rejection of the application for registration more likely.

Secretary's report; the Treasurer's report; the election of Officers, Trustees, other Committee members, and elective Auditors; any other business. 	The Chairman may chair the meeting with the invitation of the president. The Hon. Secretary shall display on the Club noticeboard for a period of not less than fourteen days, an invitation for nominations to fill the vacancies that have or will have arisen. The notice will provide for the name and signature of the nominee and the signature of both the proposer and seconder. If there are fewer nominations than vacancies the Committee may co-opt any Club members they deem fit to sit on the committee.	RULES 2.5
21	LICENSING HOURS. The permitted hours for the supply of intoxicating liquor shall be those specified by the local licensing authority. The Club shall open at the discretion of the Committee within the permitted hours.	RULES 2.6
22	GUESTS. Any member may introduce two guests at any one time to the Club. No person whose application for membership has been declined, or has been expelled from the Club shall be admitted. The member introducing guests to the Club shall be responsible for the behaviour of their guests and shall enter their names and addresses together with their own names in the book provided for this purpose and a donation to Club funds shall be made. No guest shall be permitted to purchase alcoholic liquor. Guests may be introduced up to three times in any one year, after which they will be invited to apply for membership.	Not implemented.
